DONATION AGREEMENT

This Agreement is made by and between:

The Federal State Budgetary Institution of Culture "The State Russian Museum", hereinafter referred to as "Museum", duly represented by Vladimir Gusev, General Director, performing his functions on the grounds of Statute, on the one hand,

and

an individual, visiting the Museum official cite (www.rusmuseum.ru), acting on their own behalf and in their interests (hereinafter referred to as "Donor"), on the other hand, each hereinafter referred to as "Party", and together as "Parties", in order to contribute to the Museum activities in the sphere of culture and art, guiding by the provisions of Federal Law of 11.08.1995 No. 135-FZ "On Charity and Volunteering", taking into account the donor's voluntary and selfless intention to support the Museum in carrying out its statutory activities, as follows:.

1. Subject Matter

1.1 The Donor hereby agrees to transfer to the Museum a donation in roubles in the amount determined by the Donor, but not less than 50 (fifty) roubles, in order to support the Museum's activities in the sphere of culture and art and to be used by the Museum as part of its statutory activities, hereinafter referred to as "Donation".

The Donor has the right to transfer a Donation for the implementation of a certain programme listed on the official website and for purposes which can be realised using the donations received from visitors of the official website of the State Russian Museum. For these purposes, when transferring the funds, the Donor should choose the name of a certain programme using the functionality of the Museum's official website. In the absence of a choice of a certain programme, the Donations shall be transferred to the Museum for the purpose of its statutory activities.

The Donation made by the Donor according to the Agreement for the implementation of any programme offered on the official website, or for the statutory activities of the Museum, involves its partial use for the compensation of the expenses of the State Russian Museum related to the organization of fund raising indicated in clause 2.5 of the Agreement.

- 1.2. The Museum agrees to accept the Donation specified in clause 1.1 of the Agreement and bears obligations in accordance with this Agreement.
- 1.3. The amount of the Donation is fixed and cannot be changed unilaterally by any of the Parties. From the moment the Donation is transferred, its cancellation is allowed only in the cases established by clause 5, Article 582 of the Civil Code of the Russian Federation.

2. Obligations of the Parties

- 2.1 The Museum shall not use the Donations for any other purposes than the purposes set out in clause 1.1 of this Agreement.
- 2.2 At the written request of the Donor, the Museum shall submit a written report on the use of the Donation pursuant the purposes designated by the Donor when transferring the Donation.
- 2.3 The Museum shall submit to the Donor a confirmation in electronic form specifying the sum donated by the Donor.
- 2.4 The Museum shall arrange the collecting of donations via the official website of the State Russian Museum through a separate agreement with an entity and/or credit institution and using the funds received as Donations.

- 2.5 The Donor makes the Donations by way of transferring the funds to the Museum's account via the official site of the Museum.
- 2.6 The Donation shall be deemed made by the Donor at the moment the funds are written off from the Donor's account.
- 2.7 Prior to transferring the Donation, the Donor shall:
- 2.7.1 Read this Agreement, having the right to download it from the Museum's official website where collecting of donations from the website visitors is arranged;
- 2.7.2 Confirm that he/she is an individual (legal entities shall make Donations through a separate agreement with the Museum);
- 2.7.3 Make sure that he/she is acting in good faith and offering selfless support to the Museum's activities.
- 2.8 For the purpose of executing this Agreement and transferring the Donation, the Donor shall submit personal data, including his/her bank account details by way of filling out an electronic form offered on the Museum's official website. By filling out such form, the Donor agrees his/her personal data to be processed for the purpose of performing this Agreement.

3. Change of the Donation Designation

3.1 A change of the Donation designation is allowed if the circumstances have changed so that it becomes impossible to use the Donation as it was initially envisaged. In such case, the Museum shall notify the Donor in writing, and the Donor shall express his/her consent or non-consent for the use of the Donation for other purpose.

4. Final Provisions

- 4.1 This Agreement is executed, performed and construed in accordance with the applicable laws of the Russian Federation.
- 4.2 This Agreement is deemed signed and comes into effect when the Donation transfer is made by the Donor via the official website of the Museum against filling out the electronic forms necessary for the funds to be transferred and for receiving the electronic receipt confirming the Donation.
